The owner of the bestwholesalecompany.com website is bestwholesalecompany.com, which is the administrator of your personal data.

This Privacy Policy sets out how we process information collected on bestwholesalecompany.com website and explains why we need to collect certain data about you. Therefore, before using the bestwholesalecompany.com website, read this Privacy Policy.

We care about your personal data and are committed to ensuring its confidentiality and protection.

Personal data we collect:

When you access bestwholesalecompany.com, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and certain cookies installed on your device. In addition, when you browse the site, we collect information about the individual websites or products you view, what pages or phrases you entered in the search engine that directed you to our Site and how you use it. We refer to this information we automatically collect as "Device Information." In addition, we may collect personal data that you provide to us (including, but not limited to, name, e-mail address, payment information, etc.) at the registration stage to enable the performance of the contract.

Why do we process your data?

Our overriding priority is to ensure the security of customer/user data, which is why we can only process limited data to the extent that it is strictly necessary to maintain the functioning of the Website. The information collected automatically is used only to identify potential cases of abuse and to compile statistical data on the use of our Website. These statistics are not collected in a way that allows the identification of a specific user of the system.

You may visit our Website without having to reveal your identity to us or provide us with any information that someone could use to identify you as a specific, identifiable person. However, if you want to use some of the features of the Website, or want to receive our newsletter, or provide other information by filling out a form, you can provide us with your personal data, such as e-mail address, name, surname, city in which you live, company, organization, telephone number. You may opt - out of providing us with your personal information, but you may not be able to use some of the features of the Site. For example, we will not be able to send you our Newsletter or contact you directly on the Site.
